REFUND OF FEES DUE TO CANCELLATION OF ADMISSION FOR BOTH AIDED AND SELF FINANCED PROGRAMS

The following refund rules are applicable for both aided and self- financed programs:

1. Refund the fees if the application has been received within 1 to 7 days, from the date of commencement of the term then the refund is 90% of the total fees.
2. If application has been received between 8 to 15 days, from the date of commencement of the term then refund is 70% of the total fees.
3. If application has been received between 16 to 29 days, from the date of commencement of the term then refund is 50% of the total fees.
4. If application is received after one month, from the date of admission then NO refund will be given.
5. All deposit fees are 100% refundable.
6. The refund will be given within a month from the date of application for refund.
7. Refund will be applicable only for tuition fee.
8. The Processing fees will be of Rs.1000/- and applicable at any point of time of cancellation.

Note: Fees deduction will be as per total fees only and not as per the instalment amount paid.

These rules will be applicable to all the programs under Dr. B.M.N. College of Home Science.





To consider refund rules for both aided and un-aided programmes.

RESOLUTION

Resolved that, the following refund rules be applicable from Academic Year 2017-18, for both aided and unaided courses:


1. Refund the fees if application received before 1 to 7 days is 10% of the total fees from the date of commencement of term.
2. If application received between 8 to 15 days then refund is 30 % of the total fees from the date of commencement of term.
3. If application received between 16 to 29 days then refund is 50% of the total fees from the date of commencement of term.
4. If application received after one month then no refund will be given from the date of admission.
5. All deposits fee 100% Refundable.
6. The refund cheque will be given within a month from date of application for refund.
7. Refund will be applicable only to tuition fees.

These rules will be applicable to University departments and conducted colleges.

Further resolved that, the University shall reserve the right to change the above rules at any point of time.
